Goldstar Towncar & Limousine Service has adopted it's own set of guidelines to ensure the safety of all concerned. We also acknowledge the Bureau of Health & Substance Abuse Pledge. Both our guidelines and Prom Promise will be followed. Please read over them carefully. Please provide the required information and return to Goldstar Towncar & Limousine Service.

- ◆ Driver has the right to inspect any and all bags, backpacks for alcohol, illegal drugs and tobacco products.
- ◆ Itinerary needs to be presented to Goldstar Towncar & Limousine Service prior to reservation date.
- ◆ The adult purchasing the contract or the contact parent must approve any changes in itinerary after departure. Driver will call contact parent or purchaser if passengers request a change.
- ◆ Driver will provide his/her vehicle cell phone number to the contract purchaser or contact parent.
- ◆ A contact parent's name and phone number **MUST** be provided to the driver. Contact parent needs to be available by phone for the length of the contract. In the event of a violation or breach of contract, the contact parent will need to provide transportation for the students.
- ◆ Termination of this contract will occur in the event of ANY violation or breach of contract.
- ◆ This form needs to be signed by purchasing adult, contact parent and student and be returned along with reservation contract and deposit.

A contact parent's name and phone number **MUST be provided to the driver. Contact parent needs to be available by phone for the length of the contract. In the event of a violation or breach of contract, the contact parent will need to provide transportation for the students.**

PASSENGERS' AGREEMENT FOR LIMOUSINE SERVICE

The consumption of any alcoholic beverage is unlawful when consumed by a minor. There will be no alcoholic beverages transported in the passenger compartment of the vehicle. Also, no alcoholic beverages will be carried in the trunk or any other locked compartment of the vehicle. This rule shall apply to any and all other illegal substances. If, at any time, any of the passengers are found to have in their possession, or have been at any time during the course of the service been consuming any alcohol or an illegal substance, the service shall be terminated. All money shall be forfeited and a parent shall be notified. Driver has the option of returning to point of pick up or ending service at point of infraction. Driver shall also have the right to examine all bags or parcels to be placed in the vehicle to determine if they contain any illegal substances. Due to the high risk insurance factor, the moon roof and divider windows will not be operational.

A separate signature of all under age passengers is required to ride in the vehicle. Also, please print full name immediately to the right.
